

## **Zone Resources Inc. Announces Private Placement**

**April 12, 2010:** Zone Resources Inc. (TSX-V: ZNR) (Zone) has arranged a non-brokered private placement of up to 3,000,000 units at a price of \$0.15 per unit for total proceeds of up to \$450,000 subject to the approval of the TSX Venture Exchange.

Up to 3,000,000 units will be issued as non flow-through units consisting of one common share and one full warrant. One full warrant will entitle the holder to purchase one additional common share of the Company at a price of \$0.18 per share for the first year, \$0.23 per share in the second year, and \$0.28 per share until expiration in third and final year.

The proceeds of the private placement will be used for exploration work on the Company's mineral properties and general working capital.
